▪ Official 2019 Rules

The winners will be selected solely on the basis of the following criteria:

1. Members may apply only by submitting a signed and completed SFEFCU Graduate School Scholarship Application along with other required documents. Applications that include an electronic signature or that have been faxed or scanned will NOT be accepted.
2. Applicant must have a **current** and **active account** and have been a primary member of SFEFCU for at least one year prior to the application deadline as stated below. Applicant must already have been accepted into a graduate degree program at a regionally accredited university or college.
3. The graduate school's letter accepting the student into the graduate degree program, must be submitted with the application.
4. Mailed applications must only be sent to the above address and be postmarked on or before Friday, October 25th, 2019.
5. Hand delivered applications may be submitted at any of our seven locations on or before close of day on Friday, October 25th, 2019.

APPLICATIONS NOT RECEIVED BEFORE CLOSE OF DAY ON OCTOBER 25th, 2019, AND WHICH ARE INCOMPLETE, MISSING REQUIRED DOCUMENTS OR NOT MEETING THE MINIMUM REQUIREMENTS, WILL NOT BE CONSIDERED.

Graduate School Scholarship Program

Ten (10) \$1,000 Graduate School Scholarships will be awarded to qualified applicants. Winners will be selected by a lottery drawing.

Winners must qualify and submit the required documents listed below for reimbursement within 60 days of the Graduate Scholarship notification or forfeit the scholarship. When the confirmed documents are received, the funds will be placed in the winners' account within 30 days.

1. An **OFFICIAL** transcript showing a passing grade for the **fall** quarter on Masters/Doctoral Program course(s) at a regionally accredited university or college.
2. College Billing/Account Summary for student showing the balance paid for the **fall** quarter.

Scholarship funds cover tuition only and begin with the **fall** term of the year the scholarship is awarded. Tuition reimbursement by employers, etc. will not affect the ability of the winner to receive the award money.

Applications will be accepted from Monday, September 9th to closing time on Friday, October 25th, 2019 and the scholarships will be awarded in late November.

Applicant can already be in graduate school and, **if not a previous winner of this graduate scholarship**, can apply in more than one year.

Undergraduate Hubert O. Sibley Florida Prepaid College Tuition Scholarship winners from 2004 or more recently, may apply.

Selection of Scholarship Winners

Applicants submitting completed applications in compliance with the requirements will be assigned numbers. The winning numbers will be selected by lottery by the SFEFCU Board of Directors and Supervisory Committee with a CPA or attorney present.

Graduate Scholarship winners will be notified by telephone or mail.

Photographs of the winners may be taken by the Credit Union for use in Credit Union publications and may be released to the news media. Winners must contact the SFEFCU's Marketing Department to have their picture taken or they may submit an appropriate photograph.

The members of SFEFCU's Board of Directors, Supervisory Committee and members of their immediate families are ineligible for this scholarship.
